DEMAND XXIX-STATIONERY AND PRINTING.

Dr. H. Parameswaran : 'Sir, I rise to move for a supplementary grant of Rs. 4,00,000 under Demand XXIX - Statjoneryand Printing.

In support of this may I explain to the members of the House that the budget grant for this year is Rs 2,50,000. It was more or less expected to cover the needs of this year. However with the beginning of this year, great anxiety was felt lover the possible shortage over stationery materials required in larger numbers for the increased activities of the Registration Department, the Anchal Department, etc., Therefore Government had to make special arrangements with the Government of India for the supply of special paper for these purposes. These demands have increased to the extent of Rs. 4 lakhs on that account. When these materials arrive here, we must be in a position to meet the bills without any delay. This provision is therefore very necessary.

Further, members are already aware that early this year, an unexpected activity had to be taken up by Government by the manufacture of standard note books. An extra expenditure to the extent of Rs. 3 lakhs was incurred therefor. But, that arrangement was able to save the people an expenditure amounting to Rs. 7 lakhs over costlier note books. Note books at a reasonably low price were thus supplied to the schools and colleges just in time to meet their needs. These expenses could be recuperated by the sale of these books. However we have been forced to stock paper, against such contingencies in future and it is expected that a part of this supply may be left over for the next year. Hence, I propose the demand for the acceptance of the House

The question that Government be granted a sum of Rs.4,00,000 under Demand XXIX—Stationery and Printing was put to vote and carried.

The grant was made.

111 scientific materials has gone up very high and 'so it is cheaper to have the repairs done locally. By effecting such repairs, there is considerable saving as new purchase at high rates is avoided. The department is self-supporting so to say. Therefore, Government have felt the need to continue this repair section for another six months. At present, the present sanction is only for the first six months of the current year. Therefore, I move for the continuance of this department for the next six months as well.

The question that Government be granted a sum of Rs. 1,635 under Demand XXX-Miscellaneous Departments 35 c. Stores Purchase Committee was put and carried.

The grant was made.

It says :--

mit "Your telegram dated 28th December. Supplies of milk from South Africa shipment made. Supplies expected soon" That means we are getting a very big proportion of the milk from South Africa. That means, more than 80 per cent of the total expected for the whole of India is to be given to Travancore.
