Regarding the amount spent for the purchase of stores to meet the requirements of the various departments.

- 355. Mr. K. M. Kunhi Moideen (Kattur). Will the Government state:—
- (a) the approximate amount annually spent for the purchase of stores to meet the requirements of the various departments;
- (b) whether they have constituted any central agency to make the purchase co-ordinate, efficient and economic?
 - Mr. T. S. Narayana Ayyar (Secretary to Government).—
 (a) Rs. 3,76,740-8-0.
- (b) No; but the question of efficiency and economy is never lost sight of in making the purchases.
- Mr. K. Kunhi Moideen (Kattur).—Will the Government kindly inform the House whether in making these purchases the Government have approached the Government of India Stores Department.
- Mr. T. S. Narayana Ayyar (Secretary to Government).— It is not found necessary because our present system is working satisfactorily and economically.
- Mr. K. M. Ibrahim (Cranganur).—Has not the establishment of a central agency resulted in more efficiency and economy elsewhere?
- Mr. T. S. Narayana Ayyar (Secretary to Government).— It is a matter of opinion.
- Mr. K. M. Ibrahim (Cranganur).—I am asking for the information of Government whether they have noted that the establishment of a central agency has worked more efficiently elsewhere.
- Mr. T. S. Narayana Ayyar (Secretary to Government).—
 They are not in a position to say that.

- Mr. K. M. Kunhi Moideen (Kattur).—May I know what portion of the articles purchased is made in India?
- Mr. T. S. Narayana Ayyar (Secretary to Government).—Perference is always given to goods manufactured in India. It is only in exceptional cases that foreign made articles are purchased, for instance I can say with regard to stationery articles.
- Mr. K. M. Ibrahim (Cranganur).—Are swadeshi things preferred in this connection?
- Mr. T. S. Narayana Ayyar (Secretary to Government)—Yes.
- Mr. K. M. Kunhi Moideen (Kattur).—Are the Government aware that a central agency has been formed in Travancore recently for the purchase of stores?
- Mr. T. S. Narayana Ayyar (Secretary to Government).—Yes; I am aware.
- Mr. K. M. Ibrahim (Cranganur).—Then why did the Hon' ble Member say that he was not in a position to say that elsewhere it was working satisfactorily? (Loud laughter)
- Mr. T. S. Narayana Ayyar (Secretary to Government).— I am aware of it as a physical fact just as we are all here today.
