Mr. K. M. Kunhi Moideen (*Kattur*).—How was it possible to give the answer without knowing the statistics?

Mr. K. P. Kannan Nayar (*Secretary to Government*).—We know as a matter of fact scientific instruments, watches, etc. are not manufactured in India. There are many other things which are not manufactured at present in India.

Mr. P. Kumaran Ezhuthassan (*Wadakkancheri*).—Will you mention one?

Mr. K. P. Kannan Nayar (*Secretary to Government*).—I have mentioned many.

Mr. C. R. Iyyunni (*Trichur South*).—Is it the view of the Government that such of the things as are made in India will be purchased?

Mr. President.—The policy of the Government is to purchase Indian made goods whenever they are available.
