Shri A. Thanu Pillai : I have just to offer one criticism about this demand. It is difficult to oppose any of these items. One outside the Government cannot say what is really wanted. The expenditure on General Administration is increasing unduly. I only want the Government to realise this fact that they should try to see that expenditure on this account is kept as low as possible. Expenditure under this head should not be allowed to increase to such an extent. The Secretariat should show a good example to the departmental heads and induce them to see that expenditure is kept as low as possible. That I am afraid the Secretariat is not doing. That is all what I have to say on that.
