Procedure To Be followed For Raising 'Point Of Order'

Speaker: Order, Order.

The Hon'ble Members who desire to raise points of order may keep in mind the following procedure, besides the provisions contained in Rule 281 and 282 of the Rules of Procedure and Conduct of Business in the Kerala Legislative Assembly, so that there could be better conduct of business in the House.

(1) A member who has a point of order should stand up and say "point of order". He should not proceed to formulate it until the member is identified by the Chair. Only after he has been identified, he should proceed to speak on his point of order.

(2) When a point of order is raised, the member who is speaking must give way. The point of order is an extraordinary process which, when raised, has the effect of suspending the proceedings of the House.

(3) While formulating a point of order, a member should necessarily quote the specific Rule or the provision of the Constitution relating to the procedure of the House which might have been ignored or neglected or violated. There have been many instances when other matters have been raised in the House in the garb of points of order.

(4) On a point of order, a member is not entitled to go into explanation of the subject under discussion. There cannot be a point of order on a point of order.

(5) When a point of order relating to a particular business before the House is raised, the time taken for the disposal of the
